1—Introduction



BocaVision Thin Clients enable inexpensive access to corporate (WinFrame and MetaFrame) network servers. Built-in browser software with open ISP support provides a variety of user options. Configured with a 10BaseT Ethernet connection, monitor (or TV), keyboard, mouse and/or printer, BocaVision delivers exciting network access solutions.



2—Installing Server Software

Overview of the BocaVision Network Configuration

The diagram on the next page represents a sample network configuration. Installations will vary. Generally, however, workstations are connected to an RJ-45 wall jack with 10BaseT cable running to a centralized hub. The network server is connected to one of the ports in the Ethernet hub.



Introduction to Server Software

The bundled Server Software (on CD) allows BocaVision Thin Clients to be used with a Microsoft[®] Windows NT[®] Server 4.0, Terminal Server Edition, and Citrix[®] MetaFrame[™] or Windows NT 4.0 and Citrix WinFrame to run Windows applications.

This section of the Administrator's Manual describes how to install the Server Software and set up and configure a Microsoft Windows NT Server 4.0 Terminal Server edition (WTS) or Windows NT Server 4.0 to enable BocaVision Thin Client devices to boot from and use a MetaFrame or WinFrame for loading Windows applications.

The sample configuration values presented are for demonstration purposes only. Use configuration values which are appropriate for your installation site. Microsoft DHCP server supplied with the NT 4.0 product is used to assign IP addresses to the client devices.

It is assumed that you have a working WTS 4.0 system and are familiar with the following:

- Microsoft Windows NT Server 4.0 or Windows NT 4.0 administration and configuration
- Citrix MetaFrame or WinFrame administration and configuration
- Networking TCP/IP protocol

Server Requirements

Software:

• Microsoft Windows NT Server 4.0, Terminal Server Edition and Citrix MetaFrame 1.0 (or later) or Windows NT Server 4.0 and Citrix WinFrame.

Hardware:

- Standard minimum requirements for Windows NT plus 5 additional MB of free hard disk space.
- Memory: 32MB (Server)

 4-12MB (per user depending on the application).
 The page file should be at least one and a half (1.5) times that of , but not more than double the amount of RAM (example: if RAM is 8MB, page file should be between 12MB and 16MB).
- LAN: Ethernet 10BaseT network interface and cabling

Client Systems Requirements:

- All systems networked using an Ethernet 10BaseT network.
- VGA-compatible monitor (Super VGA or better preferred).

Prerequisites

It is assumed that Windows NT 4.0 Terminal Server Edition or Windows NT Server 4.0 has been installed and configured prior to continuing. Also ensure that the network is running correctly and that the following protocols have been installed and are operating correctly:

• TCP/IP

Make certain that Citrix MetaFrame or WinFrame has already been installed and configured, including support for ICA-TCP sessions, and that user licenses have been added.

Installation Sequence Overview


- Install the Server Software from the ThinBoot CD by following the instructions on the next two pages.
- If you have not done so already, install the Microsoft DHCP server using the Network option from the Control Panel. The Windows NT installation media is required for this.
- Add a user, "ThinBoot" with a password of "thinboot". This is required for the client to attach to the server.
- Set up workstations. Refer to the User's Handbook for cabling and component connections. The Hardware Reference Guide on the Installation CD (in PDF format) provides instructions for connecting the BocaVision unit to a television and VCR.



NOTE: If during MetaFrame or WinFrame installation, you chose to reassign the server's drive letter designation, then substitute the appropriate drive letter.

ThinBoot Installation

IMPORTANT: Make sure the BocaVision WT120 CD is present in your CD-ROM drive. Windows NT will auto-detect the CD and you will be presented with the Main Menu as shown to the right. Select one of the four options or exit. To re-start the CD manually, click the **Start** button, then **Run**. Type **D:\START** and click **OK**. If 'D:' is not the CD-ROM drive letter, substitute the correct letter. At the main screen, you may select any of the four options presented. Continue on the next page for additional option screens.



NOTE: When you install the ThinBoot Software, a BocaVision Client Administrator Control utility is also installed. This allows you to set or change Boot options, Browser Options, Proxy Server options, as well as the Citrix Server IP address or name. Simply click the **Start** button, then **Programs**. Select the **BocaVision** Group and choose **BV Client Administrator**. See *Section 4—Advanced Configuration Options* for details.



- Choose Terminal Emulation Solutions for three trial modules: TunEMUL, TunNET, and SQL.
- Free productivity software. Full documentation included. See next selection screen.
- View manuals and documentation using Adobe's Acrobat Reader. See Appendix E for instructions on its use.

Configuring the Server

Sharing the Boot Directory

- 1. Open the Windows NT Explorer by clicking on **Start**... **Programs**... **Windows NT Explorer**. Browse to the directory where you installed the ThinBoot Server Software.
- 2. Right-click on the ThinBoot directory and select Sharing.
- 3. Click on the **Shared As** radio button and type "ThinBoot\$" in the share name box.
- 4. Click on the Permissions button to open the Access through Share Permisisons Window and set them to "Everyone" if not already set. Click OK to close this window. A pop-up box will appear stating that resources will not be accessible from MS-DOS workstations. Click **Yes** to continue.
- 5. Click **Apply**, then **OK**. Close the Explorer.

Adding the Default ThinBoot User

- 1. Open the **User Manager for Domains** (found in **Administrative Tools**).
- 2. Select the User ... New User menu option.
- 3. Type "ThinBoot" in the User Name field. Next, type "thinboot" in the **Password** and **Confirm password** fields.
- 4. Make sure only the **User Cannot Change Password** and **Password Never Expires** boxes are checked.
- 5. Click on the **Groups** button, select **Users** in the **Member Of:** box and click **Remove**.
- 6. Click **OK**, **Add,** then **Close**.
- 7. Select the user "ThinBoot". On the **Policies** menu, select **User Rights**...
 - In the **User Rights Policy** window, select **Log on Locally** from the **Right** drop down menu..
 - In the **Grant** pane, select **Everyone**, (if it is there) then press **Remove**.
 - Click OK to close the User Rights Policy window.

• Close the **User Manager** window.

Default ThinBoot user setup is complete.

The above has created a user "ThinBoot" with a password of "thinboot". This user has permissions allowing a mount (to allow booting of the BocaVision unit), but not a login.

Configuring the Microsoft DHCP Server

These instructions assume that the DHCP Server has not yet been installed. If you have already installed the DHCP server, skip this section and continue with "Overview of the Client Boot Sequence".

- 1. Install the Microsoft DHCP server using the **Network** option in the **Control Panel**.
- Click on the Services Tab, then the Add button. Select Microsoft DHCP Server and click OK twice. You will then need to restart the computer before continuing.
- 3. Run the DHCP Manager application (inside Administrative Tools) and configure it as follows:
- 4. Double-click on the **Local Machine** and then the menu option **Scope... Create.** Add start and end IP addresses for the IP address pool and fill in your subnet mask. You may optionally type in any IP address you wish to exclude, as well as configure the "Lease Duration" options, and type in a name and comment in the appropriate fields.


- 5. Click **OK** and then answer **YES** to activate the new scope.
- 6. Select the **DHCP_Options** ... **Scope** menu option and make the following option active with the value:

067 Bootfile Name: \\<Computer Name> \Thinboot\$\!Boot

where <Computer Name> is the name of the computer (as shown in the **Network dialog box** in the **Control Panel**.

6. You will also need to add the **'003 Router'** option, using the address of the Server.



7. Select the **Scope ... Add Reservations** menu option and then add the reserved IP addresses for the client machines. For example:

This **IP address** will be allocated to the specified client. The **Unique Identifier** is the Ethernet MAC address (physical address) of the client, which is found on the outside of the box or on the bottom of the unit, and will be displayed on screen when the unit is switched on. Other clients can be added using this method, however, we recommend testing with one client initially.

Close the DHCP Manager application. It should now be possible to connect the client to the network. Power on the client system and ensure that it is able to find its IP address from the server. If all elements have been correctly configured, the clients should boot into the opening screen similar to the example shown here:



Client Boot Sequence

When the client system is powered on, its boot sequence is as follows:

- 1. Client broadcasts its physical (MAC) address in a bootp message.
- 2. The DHCP Server recognizes this message and checks its database to see if the hardware address is listed. If so, it sends a bootp reply to the client, which includes the client's IP address, netmask, and bootfile location. The client reads its IP address, netmask, and bootfile location from this reply, and any remaining information is discarded.
- 3. The client logs in as user 'ThinBoot' with the password 'thinboot' and runs the specified bootfile, which downloads necessary software to the client and presents the opening screen as shown previously.

3—Configuration Options

NOTE: When you install ThinBoot Software, a BocaVision Client Administrator Control utility is also installed. This allows you to set or change Boot options, Browser Options, Proxy Support for the Browser as well as the Citrix Server IP address or name. Simply click the **Start** button, then **Programs**. Select the **BocaVision** Group and choose **BV Client Administrator**.

1 Select ThinBoot Folder

This field shows the current ThinBoot folder being configured.

- To choose a different folder, click on the Folder button and browse to the new location. If you have made changes to the current configuration, you will be asked to confirm or discard these changes.
- Click OK to update the BocaVision Client Administrator with information from the new ThinBoot folder.



BocaVision Boot Options

- If you select the "Boot to browser menu screen" option, the BootOpt file located in the /ThinBoot/Config directory is updated and Sys\$BootOption is set to 0.
- If you select the "Boot into Windows Session" option, the BootOpt file located in the /ThinBoot/Config directory is updated and Sys\$BootOption is set to 1.
- If you enter any value other than 0 or 1, you will receive an error message.



- When you edit the Citrix Server information, the line <NTConnect\$Server> in the ICA file (located in the /ThinBoot/ Config directory) is set to the new value you have entered.
- The Client Administrator will check that the information entered is either an IP address or a server name; if not, an error message is displayed. You will need to re-enter a valid IP address or server name.

Checking this box enables the BocaVision Browser to access the Web through a proxy server.

- To activate Proxy Support:
 - 1. Place a checkmark in the box. The field then becomes active.
 - 2. Enter the IP Address or URL (without "http://"), followed by a colon (:) and the port number for your proxy server.
- Some examples are:

www.bocaresearch.com:8080 192.68.21.0:80



Here, you may edit the following:

• **Default URLs for Home and WebMail pages.** Changing this information appends the entered URLs to the following lines in the Browser file (located in the \thinboot\config directory as follows:

Home URL: Set NCFresco$DefaultHome http://
Email URL: Set NCFresco$Email URL http://
```

• **Default Gateway IP, DNS Server IP, Domain Name, Subnet IP**. This allows you to change the default addresses/names for these parameters. When this information is changed, the following lines in the setupnet file (located in the /ThinBoot/Config directory) are updated:

Default Gateway:	bin:route -e add default
DNS Server:	set inet\$resolvers
Domain Name:	set inet\$localdomain
Subnet:	bin:ifconfig ei0 netmask

• **Screen Saver**. This allows you to change the default number of seconds of system idleness before the Screen Saver is activated. The default is 300 seconds (or 5 minutes). The value entered in this field must be a decimal number, otherwise an error message will result.

Press **Save** to accept your edits. All fields are once again checked for proper syntax and the appropriate files updated. You will then receive a confirmation box stating "your changes have been saved"; click **OK**.

If you press **Exit** without saving the changes, a warning message is displayed: "Are you sure you want to abandon your changes and exit without saving?" You may click **Yes** to exit the application, or **No** to return to the application with the information left unchanged.

4—Troubleshooting

If your installation fails to operate correctly, check the error message received and refer to the relevant paragraph below:

Cannot find a bootp server

This means there is a problem with the network connection or the BOOTP server. Check all network connections. Make sure the DHCP server is installed and running and it is configured correctly. Check that the client machine is configured **not** to use static IP addressing. If some clients boot correctly, but one does not, check that the particular client's MAC address has been correctly entered into the DHCP Manager. (Scope | Active Leases, select IP address then Properties)

I/O error in server browser

Usually occurs when the <code>OO3 Router</code> entry in the DHCP Manager (DHCP Options \mid Scope) has not been set up correctly. Check that you have entered the correct IP address of the server.

The Citrix Server you have selected is not accepting connections

Most likely the Citrix server has not been configured correctly. Check that the ica-tcp session is installed and enabled (use **Terminal Server Connection Configuration** in **Administrative Tools**). Check also that Logons are enabled (select the ica-tcp connection, then click on **Connection**...**Edit**... and then the **Advanced** button).

Error: Cannot find given server (Error number &1660A)

This error can result from a number of factors. Check the following:

• The server Computer Name has been configured correctly in the DHCP Manager 067 Bootfile Name option – this must be the same as is configured in the **Control Panel... Network... Identification** field. Note that the case of the letters is unimportant. • The NetBEUI protocol is running correctly (**Control Panel... Network... Protocols**)

Error: Share name does not exist (Error number &16623)

Make sure the Share name entered in the DHCP Manager **DHCP Options ... Scope** 067 Bootfile Name is correct.

Error: File 'Lanman::Thinboot.\$.!Boot not found (Error number &D6)

This will occur if the !boot folder does not exist in the client's boot path (ThinBoot\$), if the !Run file does not exist in the !boot folder, or if the entry in the DHCP Manager **DHCP Options... Scope** 067 Bootfile Name is incorrect – in this latter case the file name in the error message will change according to what has been entered.

Bootfile name has not been configured by bootp

Check that the client has not been configured for static IP addressing. This can be checked by holding down both ALT keys and rebooting the client system.

Error from server (Error number &1660C)

This error can arise if the password for the ThinBoot user has expired, or has been set to "User Must Change Password at Next Logon". Use **User Manager for Domains** (in **Administrative Tools**) to check that the following settings are activated.

- User Cannot Change Password
- Password Never Expires

Network Protocol Error (Error number &1660F)

This error can occur if the user ThinBoot has been deleted or is missing. Add the user using **User Manager for Domains** (in **Administrative Tools**). The password should be set to the value "thinboot".

Error Access not allowed (Error number &166B4)

This error will occur if the user ThinBoot password is incorrect or missing. Edit the ThinBoot user using **User Manager for Domains** (in **Administrative Tools**). The password should be set to the value "thinboot".

Error: User account has been disabled (Error number &1663D)

This error will occur if the user ThinBoot has been disabled. Edit the ThinBoot user using the **User Manager for Domains** (in **Administrative Tools**) and re-enable the account by clearing the "Account Disabled" box.

Error: no such connection

This error may occur when the user ThinBoot has been set to "User Must Change Password at Next Logon" and "User Cannot Change Password". These two options are not compatible with each other, and it is not normally possible to configure a user in this manner. Use **User Manager for Domains** (in **Administrative Tools**) to clear the "User Must Change Password at Next Logon" option check box.

Appendix A: Limited Warranty

Boca Research, Inc. (BRI) warrants to the original buyer of this product that the hardware is free of defects in materials and workmanship for a period of five years.

If the returned product is sent by mail, the purchaser agrees to prepay shipping charges, insure the product or assume the risk of loss or damage which may occur in transit, and to use a shipping container equivalent to the original packaging. BRI does not make any warranties in respect to the product, either expressed or implied, including no implied warranties of merchantability or fitness for a particular purpose, except as expressly provided in this agreement. If any labor, repair, or parts replacement is required because of accident, negligence, misuse, theft, vandalism, fire, water or other peril; or because of conditions outside of specifications, including, but not limited to, electrical power, temperature, humidity or dust; or by moving, repair relocation, or alteration not performed by BRI, or by any other cause other than normal use, the warranty and maintenance obligations provided herein shall not apply.

- 1. When calling Boca Research Technical Support, have the model and serial number of the BocaVision unit available:
- 2. Call our Technical Support Department between the hours of 8:00 a.m. and 6:30 p.m. EST Monday through Friday at (561) 241-8088. A technician will be available to discuss the problem(s) you are experiencing.

If factory service is required, you will be given a Return Merchandise Authorization (RMA) number. <u>Please place this number on the outside of</u> <u>the package</u> when you return the item(s) for service and reference it on any correspondence included in the package. Boca Research, Inc. will return any product which is not accompanied by an RMA number.

- 3. Refer to the Limited Warranty Statement on the previous page to determine if the product is covered under the Boca Research, Inc. Limited Warranty.
- 4. Certain parts will not be covered under the Boca Research, Inc. Limited Warranty. Dealer installed parts are warranted by the dealer. Parts which you have installed yourself are covered only by the supplier's warranties. In these cases, Boca Research, Inc. can identify which parts

are defective, but will not replace such parts until specific written authorization is received from you. The cost of parts and labor involved in making such repairs will be billed to you C.O.D.

- 5. When sending the product to Boca Research, Inc. for repairs, please be sure to include:





Appendix E: Using the Acrobat Reader

To access documentation for a BocaVision Wt120 product, return to the CD Main Screen and select **Manuals and Documentation**. At the next screen, choose **Install Acrobat Reader**. You will then be able to **View Document** by highlighting and double-clicking a title from the scroll list displayed.

Acrobat Reader 3.x is a Windows-based program from Adobe Systems which allows you to read the manual on screen. You are also able to select sections from a table of contents, search topics, and print selected or all pages of the document. See sample below.
